A message from Lucy Hughes Turnbull AO, Chair, Committee for Sydney

This report sets out some of the achievements of, and challenges for the Committee since the last AGM. It also provides a narrative to accompany the year-end accounts. It suggests some priorities for the organisation in 2014 and reflects on some of the key issues for Sydney. Sydney is undergoing new momentum and the Committee’s approach and agenda need to build on this and help shape it.

If Sydney has new dynamism so too has the Committee. We approach the end of

the year in a strong position. We have built our resources to support our priorities. Our members are our greatest asset and we have grown our membership in key sectors, with a geographical spread across the whole of Sydney, particularly Western Sydney. Our financial position is stronger than last year, we have enhanced the skills of our team, and have developed a stronger collaboration with our key partners and stakeholders. Our positive approach to developing Big City thinking for Australia’s global city is gaining support and traction. But we are never complacent and look to ensure that our operations and structures are efficient and fit for purpose. We continue to innovate and to develop.

We have built on the progress we reported at the last AGM. Our membership has in fact doubled in size since we started the renewal process at the end of 2011. I believe



our relationships and reputation with key decision-makers in government grow stronger by the month. We set out last year to become the 'go-to' body for government and the 'must-join' one for strategically minded organisations in the private, public and not for profit sectors. We are well on our way to achieving both.

At the same time we have grown our capacity and influence, we have also strengthened our finances and continue to do so. The year-end accounts show that we have reduced our deficit in one year from 25% to 7% of a much bigger turnover. We shall hear from our Chair of the Finance Sub Committee and our accountant that the upward trend in income and the effective management of costs since the year-end have further improved the situation, with the forecast for year-end FY 2014 indicating that the Committee will make a significant surplus. This will enable us to increase our reserves and to build our capacity with confidence.

The increased income from membership and very tight control on expenditure has resulted in the operating deficit being reduced from \$88,458 in the 2012 year to \$31,402 in the year under review. A continuation of these initiatives has resulted in a forecast surplus for the current financial year'

Welcoming many new members - and thanking long-term members

Behind this decisive improvement has not just been that we have attracted (as of writing) 35 new paying members in less than 2 years. It is also that we have managed to retain 95% of existing members, though we have increased the subscription fee by 50%. Whilst welcoming all the new members, I want also to thank all those long-term members of the Committee for their support and their continuing passion for Sydney.

Our member base is diverse and includes global companies, Australian icons, leading cultural and sporting organisations, some government agencies and not for profit housing associations (who we welcomed to

the Committee for the first time this year in recognition of the importance of affordable housing to Sydney). We represent no one sector: we are an independent champion and voice for the whole of Sydney, and all the stronger because of it. We are an effective vehicle for our joint aspirations to make a good city greater still.

In the last 18 months in particular we have enabled members to take more part in the development of Committee policy and initiatives by creating member-led Taskforces and the new Council of Board Advisors. The Taskforces and events have promoted work on Planning and Housing, Transport, the Liveability / Loveability of Sydney, and Sydney as a Global Talent Hub. These have proved lively and well-attended forums which have informed members, shaped Committee initiatives, developed policy and enabled key stakeholders to engage with us in a collaborative and discrete atmosphere. They have helped build those positive coalitions for change on which all cities rely and which are so important in a city like Sydney where negativity and conflict have sometimes been too much in evidence. We want to change the tone of the civic discussion about Sydney's future.

Innovating Committee Structures

We are strengthening member involvement further by implementing the decision taken by Members at the Special General Meeting to increase the maximum number of Executive Board members from 12 to 17. We are also strengthening and formalising the group of Board Advisors which we created last year, and

will institute from January 1 a twice-yearly meeting between the Executive Board and the Advisors which will add to the input of member organisations and help the Committee develop further expertise and capacity.

I am also delighted that a further innovation this year was the creation of Life Fellowships of the Committee and that by doing so we were able to recognise the contribution of two great champions for Sydney and the Committee, the Hon. Warwick Smith and our former Chairman Stephen Loosley.

We also created a new finance sub-committee (chaired by Craig Pudig) and a membership committee (chaired by Kate Jordan) within the Executive Board to increase scrutiny and focus attention on resource management and member liaison. We initiated two member surveys in 2013 and they have informed Committee policy-making and performance: the first survey showing that Members had identified new momentum in Sydney was extensively covered in the national

electronic and print media. We also plan to send a copy of this annual report directly to the CEOs of all member organisations with a note of thanks from myself as Chair for their organisation’s support.

We are open to further suggestions for innovation and involvement: we have great members and want to maximise the opportunities to harness their energies and skills. The Global Talent Hub research showed the increasing diversity of talent available and the need for organisations to create cultures and practices which embrace this opportunity. The Committee believes similarly that there is a need to encourage greater diversity in business and city leadership and will be exploring opportunities to promote that objective in 2014.

Our Greater Sydney perspective

The Committee always seeks to bring people together, to share expertise and solve problems for the benefit of Sydney and I believe that approach has resonated

with business, government, media and the community. And by ‘Sydney’ we have stressed ‘Greater Sydney’ and we meant it. Our objective is to be an effective voice and champion for Greater Sydney and in the last 12 months we have made a reality of that.

So, yes we have supported the Light Rail from Circular Quay down George Street through Moore Park and believe that our support had an impact at a critical time for the project. But we have also been strong supporters of the Western Sydney Light Rail initiative and have been strong advocates for the investment and policy initiatives – those economic development and connectivity projects – Western Sydney needs not to just meet the inhabitants of the region but also to deliver its full potential for Sydney. It is clear in a city shaped like Sydney with its CBD at one edge and with half the population now – and a majority in future – living in Western Sydney – that public policy and private initiative need to be aligned to ensure that we develop the capacity of the existing CBD, maximise the connectivity and economic vitality of Western Sydney – and make a reality of aspirations for Parramatta to be Sydney’s second CBD. The Committee’s first Issues Paper focused on these issues and we will continue to work on this Greater Sydney agenda in 2014.

Events

Much of our thought leadership for Sydney finds its way into the design and delivery of the events program and the reports or policy submissions we produce.



Our events and Taskforce meetings were intended to reflect our Priorities 2013 document or otherwise respond to the key challenges and opportunities for Sydney. Our main events and taskforce meetings have been well-attended and increasingly include government policy-makers as well as our members.

We believe this informal exchange of best practice and ideas between the public and private sectors is a virtue in itself but that it is also supporting new thinking in key government departments – as well as influencing practice in the private sector. It is also encouraging new collaborative ways of working. The full events program for the year is set out in the appendices. We welcome ideas from members of the kinds of events we should stage and the range of speakers we should invite – and any help they can offer in hosting events and securing great speakers. I'd like to thank those members who helped host and shape events this year.

In addition to the formal events program we have held more informal 'precinct-based' collaborations to help bring key partners together around a common theme or interest. We are particularly pleased to have been involved in working with partners and member organisations in and around Circular Quay and will continue with this approach in 2014.

Finally, towards the end of the year we brought our interest in learning from global cities together with our interest in digital innovation, by hosting two Committee 'Online Global City Dialogues' involving presentations from New York, San Francisco and Shanghai. Thanks to Cisco and the MCA for enabling and hosting these innovative dialogues.



Issues Papers, reports and submissions

The Committee innovated this year in the format used for its publications. We initiated a new series called 'Sydney Issues Papers' focusing on urban productivity, Sydney as a 'Global Talent Hub', and urban innovation/digital economy (see Appendix 1 for further details). All had an impact and we thank all members who helped research and deliver them. I focus on the third Issues Paper ('City of Choice: Sydney as a Global Talent Hub') as having a special significance as it shows the exemplary partnership the Committee and its members developed with the Department of Trade and Investment and our enthusiastic and informed members. This project, which involved sending a questionnaire to over 100,000 international staff members of Committee member organisations and also led to the production of an 'Official Guide to Living and Working in Sydney', involved a uniquely collaborative approach to research and policy-making. The project informed government approaches to

marketing Sydney to global talent and is also helping the private sector develop and share best practice in a new Global Sydney HR Leaders Network.

I'd like to take this opportunity to thank Deputy Premier Andrew Stoner and his team at NSW Trade & Investment for their exceptional work on this project, Dan Labbad COO of Committee member Lend Lease, for chairing the Global Talent Advisory Board and all the enthusiastic and informed Committee member organisations who have been involved. Please note that we intend building on this 'talent' theme in 2014.

Finally, we created a regular newsletter for Members and also a version for our now 900 stakeholders.

Media

The Committee's approach is to share expertise and best practice between the public and private sectors so as to improve

policy and outcomes. We prefer to base our media work on our research and only to make comments on agendas on which we are expert, fit our priorities and speak to the policy needs of Sydney. We have been successful in 2013 in attracting serious attention to our initiatives. A more detailed review of our media performance is provided in Appendix 2.

Continuing Sydney's momentum - and working with Government in 2014

The Committee stressed in several of its Issues Papers that while the current momentum of Sydney is highly positive and important for the nation at a time when the resources boom has moderated, it is crucial that the momentum is not short-lived. We must use this new energy to turn this opportunity into a strategic breakthrough in Sydney's productivity and performance. The NSW Government and the new Federal Government will be key agents in achieving this objective. The Committee will work with government at all tiers to ensure the continued momentum of Sydney, and to ensure that Sydney's vital importance to the economic success of Australia is recognised in appropriate policy initiatives and in terms of public investment in key infrastructure.

In this context it is vital that the new Federal Government and the NSW Government are as aligned as possible in terms of policy and investment for Sydney and that a new spirit of collaboration is realized. The signs are good but we will be vigilant on this agenda. The NSW Government has already shown a welcome commitment to reform and had a commendable focus

on Sydney projects. We will be keen to see both continue in 2014 and will, as we have proven already, be a firm public ally of reform and Big City thinking and projects for Sydney. We will of course be equally vigilant in monitoring the progress of the implementation of the reform program and the delivery of the infrastructure Sydney needs.

Committee performance in 2014

But then, we will also apply the same rigour to our own performance as a Committee. We are strengthening our excellent team by creating a business/office manager role to support the CEO to handle the increasing demands on our administration, events organisation and member liaison. While the team performance is partly to be judged in terms of the management of resources, the team shares with the Committee Board and members a desire to be judged on the impact of our work over time on delivering Committee priorities. Our Priorities 2013 document has guided us well and we have made progress against all themes - housing, planning, the visitor economy, transport, global talent. But we can and will do better and will make a focus in 2014 on tracking the impact of our advocacy and policy-making on key decision-makers.



The process of developing our Priorities 2014 document is already underway. Our Member survey will inform and shape this as will our new Board, Council of Advisors and taskforces. We look forward to working with all our Members in 2014 and thank all of you for your support in 2013.

The Committee's work and achievements would not have been possible without the great efforts of our CEO Tim Williams, Strategic Advisor Michelle Washington and the rest of the CFS team. On behalf of the board and all our members I would like to thank them. We are all very grateful for the work they do. It has been a great collective effort.

The Committee response supported the IAP, while highlighting the fact that the creative industries sector already plays an important role in Sydney, and noting the importance of branding Sydney to attract and retain talent within the sector.

These issues were outlined in the Case for Sydney – Key Issues paper which was handed to the Prime Minister at the meeting.

JULY

Governance and planning reform for Sydney: two sides of the same coin

The Committee for Sydney team drafted a joint submission in response to three documents open for public consultations:

1. NSW Planning White Paper
2. Draft Metropolitan Strategy for Sydney 2031
3. Future Directions for NSW Local Government – Twenty Essential Steps

“We commend the significant reform program of the New South Wales Government. It is because we regard it as a single program rather than a series of discrete initiatives that we have chosen to present a unified submission in relation to the Planning White Paper, the Draft Metropolitan Strategy for Sydney and the

report of the Independent Review Panel on Local Government. Our purpose is to stress the vital interconnections between these initiatives and the need for effective integration.

Previous submissions by the Committee have stressed, as the title of this unified submission puts it, that planning and governance reform for Sydney were ‘two sides of the same coin’. The failure to implement key elements in previous Metropolitan Strategies for Sydney, to which the COAG Reform Council drew attention, was in great part due to the governance gap in Sydney and the fact that there was no single agency responsible or accountable for delivering.” (p. 3)

AUGUST

Sydney Issues Paper 2 – #wethecity: collaborating to compete in the digital era

The challenge for Sydney is to find a way to harness together smart technology and smart governance, a better partnership between the private and public sectors and a dramatically improved civic dialogue to best exploit to the full the capacities and skills of its current inhabitants to help create better outcomes for Greater Sydney.

“Planners and decision makers need to evolve and adapt their tool-kit to have more open conversations to ensure community engagement – to engage not just with the usual suspects but also with those driving innovation.” (p. 7)


Committee for Sydney Response to the City Centre Access Strategy

“We strongly support the upfront commitment to encouraging a greater proportion of people to use public transport to access the city centre and the emphasis on walking in and around the city. There is global evidence that walkable cities add value to their assets whether commercial, retail or residential. To complement this priority, greater emphasis should be placed on ‘spreading the peak’ of journeys to increase the efficient use of the existing network” (p. 7)

Media coverage varies widely and clearly tended to peak whenever we released a report or submission. Note that references to us, or articles by us, in print increased while radio appearances reduced. We decided to focus on print journalism in 2013 though some of our work got more national TV coverage than in 2012: the research on Sydney's new momentum being a case in point, when we launched our Issues Paper 1. Our approach to media has been largely driven by the needs of

our own agenda though the Committee CEO has become a 'go to person' for media comments on key issues. We never seek media coverage for its own sake and prefer to avoid above the line controversy preferring a quieter approach to exercising thought leadership via spreading our members' expertise, developing evidence-based policy-making and publishing compelling reports on Sydney's performance, challenges and opportunities.

The term of appointment for a member of the Council of Advisors will be three years. It can be renewed but there is a maximum period of membership of 6 years.
