A message from Lucy Hughes Turnbull AO, Chair, Committee for Sydney



Momentum

This has been another year of impact and achievement for the Committee for Sydney. The report shows how we have continued the momentum from last year and in many ways surpassed it. These are not just personal observations. We know from the recent survey of Committee members that 94% say that the Committee's performance was strong or very strong over the last year. The Committee is seen to be punching above its weight

and to be creating the kind of platform for collaboration which successful global cities all have and which Sydney has long needed.

When the public, private and not for profit sectors come together in a common cause, cities thrive. The Committee exists to promote that collaboration for the benefit of Greater Sydney. In 2014 we have seen the Committee bring disparate forces together I add: we are not complacent about the performance of the Committee or the need for us to constantly improve so as to maintain our own momentum and support that of Sydney itself.

While financial performance is clearly not the only barometer of success, the audited accounts do provide firm evidence of a

growing membership and also, I believe, of good financial management. It is worth reflecting on the fact that since the renewal of the Committee at the end of 2011, we have moved from making an operating loss to a significant surplus with healthy reserves. In addition to thanking members themselves, I also want to thank on your behalf the team, our accountant and the Committee's Finance Sub Committee, chaired by Craig Pudig, for their excellent efforts on the finances. We will of course continue to keep a lid on expenditure and ensure our income matches or exceeds expectations. But the financial health of the organisation does mean we can plan for the next few years with increased confidence.

Growth in membership

At the heart of our renewal were two objectives. The first was to enable our members to play a greater role in shaping the development of the Committee's policies and strategies. The second was to thereby enable Sydney to have the benefit

of the world class expertise and capacity of our members in identifying policies and initiatives which would meet our city's challenges and exploit its opportunities. We are together helping to provide the Big City thinking required for success in a global city.

Our growing membership reflects success in attracting organisations with a passion for Sydney and the capacity to help shape it. We have grown in less than three years from just on 30 financial members to over 80. Members may recall that last year we agreed a self-imposed limit on the size of membership at 100. We did that because we wanted to be of a size that whilst giving us the resource to be effective and have real impact, did not result in us being too big or remote from members. I hope members agree that we have got this about right.

Stakeholder response

The report also testifies to the positive response we have been getting from our stakeholders. We quote some of them in the document. My own favourite is from the senior public servant who referred to the 'wise advocacy of the Committee for Sydney' in relation to the emerging Greater Sydney Commission. I believe that the positive stakeholder response is as much about how we work as it is about the content of that work.

Whilst being strong advocates of change and big city thinking, we have always sought to promote our priorities via research and a positive civic dialogue. We are persuaders and coalition-builders determined to improve the tone of debate about Sydney's future. Although we are

comfortable in using media to promote discussion about our objectives, we prefer to focus on the key issues in a cool, evidence based way and never resort to negative campaigning. Our impact on decision-makers and stakeholders is achieved through providing expertise and best practice examples from across the globe and an environment at our events which supports dialogue. Whether it's in terms of governance reform, strategic planning, public transport, policy for Western Sydney, promoting the arts and sport as essential to the 'Sydney offer', marketing Sydney for international talent or the future of financial services in Australia's only global city, the Committee is, through this approach, making its impact felt.

Issues Papers, reports and submissions

Our Issues Papers, reports, and submissions are, for us, key evidence based channels of communication and intervention in the main public policy debates. They are also attempts to shape the civic and media dialogue about the growth and future of Sydney. We had another robust performance on this front and the report identifies the key documents researched and published by the Committee in the last year. I highlight three because of the impact they had on issues of great significance.

Issues Paper 4 'Adding to the Dividend, Ending the Divide: 2014 Update' was a ground-breaking study of what Sydney's economy offers the nation and the state ('the dividend') and the need to ensure that the potential of Western Sydney was

fully exploited to the benefit of all ('ending the divide'). Of special importance in this well researched and well-argued report was the evidence that over 80% of all taxes gathered in Sydney goes to the Federal Government. This was a timely intervention in the crucial national debate about the future of the federation, the vertical fiscal imbalance between States and Commonwealth and the vital need for cities to get a new deal on funding for their key infrastructure. Cities are the main drivers of national productivity and Sydney is itself now again the producer of 23% of national wealth. We must as a nation invest in our cities and see much better policy and investment alignment between tiers of government to maximise their contribution. The narrative of this Issues Paper caught the mood of the times and the attention of decision-makers - and is a real highlight of 2014.

Unlocking the Potential: the Fintech opportunity for Sydney was the high impact report the Committee undertook with KPMG. This was the first report

researched as part of the innovative Financial Services Knowledge Hub which the Committee has established in partnership with the NSW Government. This is only the 3rd such city-based report on this key new sector of financial services to have been done in the world. It is already changing the way both government and the private sector are collaborating to develop this sector. I'd like to thank KMPG for their outstanding work on our behalf on the report, Andrew Low of member RedBridge Grant Samuel for Chairing the Financial Services Knowledge Hub and again the NSW Government Department of Trade and Investment for their continued - and imaginative - partnership with us. Such public-private collaboration around research and problem solving is exemplary.

The Committee Submission to the NSW Parliamentary Inquiry into Affordable Housing embodied the Committee approach to its role. As with all such submissions the Committee didn't just put out a document and press release and then wait for something to happen. We put together a group of members to develop thinking and advocacy and we created a platform for dialogue and collaboration with the various departments of the NSW Government interested in developing new policy around social and affordable housing. This ultimately found an expression in the Premier's exciting Innovation Initiative which has as one of its core priorities affordable housing. We expect a real policy shift from this process. I add also that we welcome the new approach to policy-making embedded in the Premier's Innovation Initiative - which is to ask the private and community sectors not just to bid for a detailed tender but to suggest what the problem actually is and then to suggest their own ways of solving it. This echoes the more social, crowd-

sourced approach to urban innovation the Committee outlined in its 2013 report #wethecity.

Next year: digging deeper on the key issues

Our strategy for next year, informed by the 2014 Member Survey and Board discussions on the future, will be to focus even more on achieving our current core Priorities. In the year of an election we clearly have an opportunity to promote our core objectives and will do so. The team will be working to ensure all events, research and advocacy reinforce the delivery of our Priorities. We have in the last year had a diverse and high quality range of events and speakers which have always attracted full attendance from members and stakeholders. In 2015 we will, while maintaining a breadth of service to members, dig deeper into the key issues for Sydney and ensure that all reports and events reinforce our core Priorities. The Committee doesn't take an academic view of our primary purpose; we are here to make change happen in Sydney. All our efforts will be concentrated on making 2015 a year of delivery in Sydney.

I wish to record formally the thanks of the Board to the Committee team and it's CEO Tim Williams for the outstanding work done on our collective behalf over the last year. This is a high performance though still a small team and I know members will want our appreciation of their contribution noted.

Governance

The Committee has played an important role in the emergence of the new **‘Greater Sydney Commission’** which will be launched by the State government at the same time as the Sydney Metropolitan Strategy.

Local Council amalgamations: The Committee campaigned for the creation of fewer but stronger councils better equipped to engage with State and Federal governments: NSW Government now supports this agenda.

Planning

The Committee’s advocacy helped secure a higher priority for Western Sydney in the emerging Sydney Metropolitan Strategy and support for a more ‘polycentric’

approach to Sydney’s growth. The Committee’s approach to ‘density done better’ also gained strong support from stakeholders.

Transport

Having supported the **CBD Light Rail** project now being implemented, the Committee also made the **Western Sydney Light Rail** project a priority: both showing what innovative council leadership and cross government collaboration can achieve

As part of the ‘public transport revolution’ we seek for Sydney, we prioritised a **Second Harbour crossing** in our submission supporting the partial leasing of the ‘poles and wires’. Our submission also promoted the need for an informed debate about new approaches to funding

Sydney as a Financial Services Knowledge Hub

Established in collaboration with NSW Trade and Investment, the Hub produced a leading edge report on *Unlocking the potential: the Fintech opportunity for Sydney* and will play its part in promoting Sydney's financial services sector.

Sydney as a Global Talent Hub

Building on last year's research into global talent, a new Committee **HR Leaders Network** was created to share best practice, support the marketing of Sydney and host Global Talent Networking events.

Future Leaders: towards 2054

Launched by the Hon. Gladys Berejiklian, MP, the Committee's **Future Leaders**

Sounding Board - a network made up of the next generation of leaders from our member organisations - is now playing a role in the creation of Committee strategy: Our review of Sydney in 2054 was shaped by their input.

A new way of involving Sydneysiders

As part of its commitment to secure involvement from younger people in the shaping of their city, the Committee created with Sydney Alliance and Youth Action Network a **Youth Housing Summit** as a new engagement approach for young people around the challenges of affordable housing.

Learning from other global cities

The Committee continued its unique **'global city online dialogue'** series enabled by CISCO and supported by MCA and Powerhouse Museum to enable Sydney to learn from the best.

Collaborations

We facilitated collaborations between key stakeholders at Circular Quay and the Western Harbour of Sydney which influenced government thinking and brought partners across the public and private sectors together to achieve better outcomes.

Green Grid for Sydney

The Committee has worked throughout the year with the Government Architects Office to promote the concept of the Sydney Green Grid with State and Federal Ministers,

members and stakeholders. Connecting and enhancing Sydney's networks of green spaces and corridors has the potential to improve the liveability, accessibility and potential for investment across Sydney.

#wethecity

NSW Government and Sydney have listened to the call from the Committee's 2013 #wethecity report - to collaborate to compete. and using digital platforms to enable Sydneysiders to help shape solutions for their city's challenges. Since the release of the report we have seen major developments on E-planning, a whole of NSW Government digital strategy and the announcement of the Premier's crowd sourcing Innovation Initiative. The Committee itself took this approach further by sponsoring SOUP, a new platform for urban innovation.



Western Sydney

The Committee played its part in **Western Sydney's emergence as a policy priority** over the last 18 months with a particular emphasis on its transport and employment needs.





JANUARY

Response of the Committee for Sydney to the Walsh Bay Arts Precinct Master Plan

The Committee response supported the development of the Sydney Arts (or Cultural) Ribbon around Walsh Bay, particularly due to the importance of the cultural sector to Sydney's economy, but urged the need for integration of agencies to deliver, and integration of the precinct with neighbouring precincts, particularly through active transport and wayfinding. We believe the precinct needs to maintain mixed-use, potentially through a Business Improvement District management model used in the UK and US.

MARCH

Committee for Sydney submission on the Inquiry into social public and affordable housing

This submission highlighted the fact that Sydney needs more housing, better equity of access and a variety of tenures to meet current demands and support growth. It argued that these could be delivered through more 'affordable housing', the development of shared equity schemes and clarification of the role of Community Housing Providers.

Feedback from the Committee for Sydney on the NSW Local Government Reform Proposals

This feedback supported the Panel's proposals for Local Government Reform in NSW and reiterated the Committee's position that Sydney should have fewer, but stronger councils, better strategic metropolitan co-ordination for Sydney and a better partnership between local and state government.

JULY

Sydney Issues Paper 4: Sydney, adding to the dividend ending the divide - 2014 Update

Following up on Issues Paper 1 of the same title, this paper updates that research. It focuses on key findings which illustrate the continuation of the divide, in the form of both the 'vertical fiscal imbalance' between the State and Federal government and the uneven spatial performance across Sydney that exists despite the current momentum in Western Sydney.

The paper highlights the significant economic contribution made by the State to the Federal Treasury and the clear gap between that contribution and what is returned to the State. It calls for a new National 'urban compact' and a 'new deal' for Sydney to be able to continue its significant contribution to national economic performance and to properly manage its inevitable growth; through a pipeline of infrastructure projects and more certain funding provisions, including the recycling of assets and innovative funding mechanisms.

The report also looks at the importance of governance in managing this growth and how the existing fractured system is holding Sydney back. It calls for a metropolitan scale of Governance and collaboration between state and federal government.

SEPTEMBER

Response of the Committee for Sydney to the Financial System Inquiry Murray Interim Report (July 2014)

The Committee response echoes the key recommendations of the earlier *Australia as a Financial Centre Report (the Johnson Report)* which sought to ensure our finance system competes effectively in the provision of finance and supporting professional and business services to global enterprise and investors, and the future development of Sydney as an internationally competitive financial services centre.

OCTOBER

Submission of the Committee for Sydney to Rebuilding NSW Discussion Paper

The Committee response welcomed the dialogue on how best to invest funds arising from the lease of NSW electricity infrastructure, reinforcing the need to invest back into critical infrastructure, with a Sydney First approach. It called for evidence-based appraisal of projects to ensure they are aligned with the Metropolitan Strategy for Sydney and

the Greater Sydney Commission. These projects should in turn fit strategically into a long-term pipeline of infrastructure projects, incorporating not only the big and new, but also smaller and less glamorous upgrades to existing infrastructure in order to ensure better efficiency of existing assets. It also called for a civic dialogue on new approaches to funding infrastructure for Sydney, drawing on interstate and international examples.

Unlocking the Potential: the Fintech opportunity for Sydney

Unlocking the Potential is the first research report published by the new Financial Services Knowledge Hub. The report has been developed by Committee member KPMG's leading financial services and banking team.

Sydney's financial services sector is a key driver of national productivity. At the same time, Sydney is also the centre of Australia's ICT industry and leads the nation in tech-start-ups. The foundations are therefore here for a thriving Fintech sector.

Research on this sector, which is crucial to the future of financial services in Sydney, has never before been done in Australia and this is one of only three reports done so far globally on this new sector. It shows that Sydney has a strong base of potential growth and an opportunity to become an Asia-Pacific Fintech hub.

SEPP 65 and the Residential Flat Design Code

The Committee's response to this consultation is currently being finalised.

Media In 2014

The Committee has focused on broadening coverage across outlets and channels and building strategic relationships in order to ensure appropriate and timely coverage on our priority areas and to maintain our bi-partisan positioning. Since last year coverage can be seen to have balanced out across the major news outlets.

By cultivating individual relationships and working with journalists to deliver a package of coverage on a specific activity, we have seen coverage peak around the release of reports, events and policy announcements which we have sought to promote or commend - in particular the announcement of the Greater Sydney Commission (April), Issues Paper 4 (July), and the announcement of Local Government Reform and the Fintech Report (late September/early October).

The clearest example of success with this approach was the promotion of our Fintech report, *Unlocking the potential: the Fintech opportunity for Sydney*. In collaboration with NSW Trade and Investment, the Deputy Premier's Office and KPMG, we worked with The Australian Financial Review (as well as the The Sydney Morning Herald) to create a series of coverage before, on the day of, and following the release of the report, including an opinion piece from the Committee's CEO.


